



MEMORANDUM OF UNDERSTANDING (MOU)

Using P.A.C.E. Health Education Modules in conducting addiction awareness activities for school and college students in Maharashtra State.

Tobacco is risk factor of six out of eight leading causes of death in India. P.A.C.E. (Prevent Addictions through Children 's Education) is a Non-Government Organisation working for preventing addictions amongst adolescent age group by health awareness programs in schools/ colleges/ slums. PACE is a group of Senior Clinicians who devoted their time, efforts and knowledge in developing the health awareness module. The module has three parts. One film, which was produced under direction of renowned director through fund raising by PACE, another film for children above 14 years of age and thirdly power-point presentations (PPT) for awareness. PPT is developed by senior clinicians who are PACE, by devoting time, energy, experience and knowledge. Thus, the health education module of PACE is an intellectual property developed by PACE members in view of creating effective awareness and protecting out next generation, as community social responsibility. Module is effective in creating behavioural change and has been confirmed through research and a research paper has been published in a renowned journal in this regard. To prevent misuse of module and in view of acknowledging the efforts of

PACE, PACE would like to make an agreement with the principal of Kisan Veer Mahavidyalaya, wai and through the Dept. Of Psychology. before sharing the module with NGO.

Roles and responsibilities of The College (The Department of Psychology)

- NGO and its members or individuals (referred here as volunteers) will use the PACE material as an awareness and prevention program for the adolescent (and above) age students.
- As all material provided by PACE is developed by PACE members so it will not permit its use or copying without permission of PACE.
- NGO/ volunteers should keep a record of all the awareness sessions and will submit a copy of activity report with photographs. (School/ college name board, presenting volunteer with slide/movie image, audience, certificate). Certificate should have all details and signs of school authority. Number of students per session should be minimum 75.
- NGO/ volunteers will be expected to contribute part of honorarium/ any donation/ commercial benefit to PACE in case any institute, school, society or funding agency has given any amount. This contribution shall be 50% of amount received as the cost of module development, and further work of PACE. Transparency is expected in this matter and discussion can be held with PACE authorities. The amount can also be adjusted in the remuneration given to volunteers.
- NGO should give feedback for modification of module if needed.
- Remuneration of program will generate from PACE on proper reporting by NGO/ volunteers and will be deposited in NGO's/ volunteer's bank account.


Roles and responsibilities of P.A.C.E.:

- PACE will share the health educational module, badge, certificates, banner design.
- PACE will conduct training program (online /off line).
- PACE will provide technical support and guidance wherever required.
- PACE will guide and help in seeking permissions of Education Officers, if need be.
