Association duly organized and existing under the laws of India having its registered office at 'MAS Bhavan' P-76, ADDL., MIDC, Satara – 415 004 (hereafter referred to as "MAS", which expression shall unless repugnant to the context or meaning thereof, include its successors, legal representative and permitted assignees) on SECOND PART

AND WHEREAS, **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** is offering UG, PG program in Arts, Commerce and Science and Bachelor of Commerce in Computer Application (B.Com, (C.A.)).

AND WHEREAS, **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)**, is a registered Association, engaged in development of associated industries AND WHERE both **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** and **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** are desirous of associating with each other to expertise students of **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** on Industrial training, Visits, will also help in conducting Expert Lectures/ Seminars / Workshops / Internship / Industrial Visits / Consultancy as an addition **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** curriculum in co-ordination with all Faculties .

Now therefore, in consideration of the premises and the actual covenants herein contained, it is agreed by both **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** and **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** as under.

1.0 Definitions and Interpretation

- 1.1 "MOU" shall mean this Memorandum of Understanding executed between **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** and **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** on 01/04/2023.
- 1.2 "Party" or "Parties" shall mean **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** and **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** individually and collectively as the context may require;
- 1.3 The headings/subheadings/titles sub-titles are only for the sake of convenience and shall not be interpreted to restrict or otherwise affect the meaning or import of the clauses, which shall be interpreted solely in light of the contents thereof.
- 1.4 Use of words in the singular includes the plural and vice versa and the masculine gender includes the feminine where applicable.
- 1.5 Where a word or phrase is defined, other parts of speech and grammatical forms of that word or phrase shall have the corresponding meanings. Any reference to 'Writing'

includes printing, typing, lithography and other means of reproducing words in visible form.

2.0 SCOPE OF THE MOU

Both **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** and **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** shall encourage interactions between the Trainer, faculty members and students of both the organizations through the following arrangements:

- 2.1 Conduction of joint projects, conferences and seminars.
- 2.2 Internship, Practical training of **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** students at industries associated with **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)**.
- 2.3 Exchange of Faculty and Industry Person for training Programs in Institute as well as in Industry.
- 2.4 **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** may depute its associated personnel as visiting faculty at **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** to teach any of the regular Course or specialized topics.
- 2.5 Would allow the industrial visits of students for half/full day to provide them with an exposure to various equipment, instrument, etc.
- 2.6 **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** may showcase its business activities at the seminar/workshop/conference/ hands on training, etc. at **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI**.
- 2.7 **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** shall provide the laboratories and Common Facility Centre (CFC) for personnel associated with **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** for joint collaborative projects.
- 2.8 Patents, Technologies available in **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** is used to Industries with the help of **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)**.
- 2.9 Fostering Entrepreneurship among the students with the help of **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)**.

3.0 Responsibility Structure

- 3.1 **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** shall provide the infrastructure of systems, LCD projector etc. for the Expert Lectures. Also the labs and other research equipment available in the lab.
- 3.2 **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** shall be responsible for arrangements & coordination for Process of necessary Appointments with Industries for Industry Internship Program, Expert Lectures as well as Visits in co-ordination with staff

& HODs **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI.**

- 3.3 **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** shall create awareness amongst its students for promotion of the activity especially Internship Program.

4.0 Certification

Upon completion of the Internship, **MANUFACTURERS' ASSOCIATION OF SATARA (MAS) & JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** will jointly conduct technical assessment for students. The students qualifying the technical assessment shall be certified with completion certificate.

5.0 Relationship

This MOU relates solely to the intention of the parties, wherein **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** and **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** jointly work together and shall not extend to any other activity or create a partnership between the Parties hereto and under any law of any country. The parties agree that it is not their intention to share any loss or profit between them in their respective fields, except to the extent expressly provided herein.

6.0 Authority to Bind

No party shall act on behalf of the other party to contractually bind the other Party under the terms of this MOU having first obtained the other Party's written agreement.

7.0 Confidential and Proprietary Information

- 7.1 "Confidential Information" shall mean all information, including the material and licenses or other information if any so given to **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI**, written or verbal, identified as confidential or of a nature that a reasonable person would understand as being considered confidential by **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** and disclosed by **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** to **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** or its faculty which is related to **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** information such as course material, training data, guidance notes, procedures, methodology, etc.

- 7.2 **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** shall not disclose **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** confidential information without first obtaining written consent from **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)**.

8.0 Termination

One year from the date of signing of MOU, unless renewed on a mutually agreed terms and condition for a further period. During the initial term or any renewal term, either party may terminate this MOU, after mutually agreed days, with prior written notice to the other party.

9.0 Assignment

This MOU shall not be assigned or otherwise transferred by any Party, in whole or in part, without the express written consent of the Other Party.

10.0 Consequential Damages

Other than explicitly mentioned in this MOU, either Party shall not under any circumstances or at any time be liable to the other under or in connection with the MOU for any special or any direct or indirect loss or damage or for any consequential loss or damage, whether direct or indirect, including but without limiting the generality of the foregoing, loss of profits, loss of production, or loss of opportunities.

11.0 Severability

If any provision of this MOU or the application thereof to any person, entity or circumstance shall be invalid or unenforceable to any extent, the remainder of this MOU shall not be affected thereby and the application of such provision shall be enforced to the greatest extent permitted by law.

12.0 Arbitration

12.1 All disputes, differences or claims arising out of or in relation with this MOU not limited but inclusive of as regards to rights, liabilities, damages, claims, breach or interpretation of this MOU between the Parties shall be referred to arbitration.

12.2 Any party shall give a written notice to other party of existing such dispute, difference or claim. On receipt of such notice within 15 days, the Principal of **JANATA SHIKSHAN SANSTHA'S KISAN VEER MAHAVIDYALAYA, WAI** and Partner, **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)** or any other persons so nominated by the respective Parties, shall meet together and try to resolve such dispute, difference or claim amicably. If such amicable solution is not arrived within one month, then the matter shall be referred to Arbitration.

12.3 The place of arbitration shall be Satara. The arbitration proceedings shall be conducted in English as per the rules of The Arbitration and Conciliation Act 1996 by three (3) arbitrators appointed in accordance with the said Rules. The Arbitration Decision shall be final and binding.

13.0 Governing Law

The agreement shall be governed by Law of the Land.

14.0 Notices

14.1 Any notice and other communications provided for in the Agreement shall be in writing in English and shall be first transmitted by facsimile transmission and/or by internationally recognized courier service, in the manner as elected by the Party giving such notice: In the case of notices to **MANUFACTURERS' ASSOCIATION OF SATARA (MAS)**.

14.2 Either Party may, from time to time, change its address or representative for receipt of notices or other communications provided for in this Agreement by giving to the other not less than 15 days prior written notice.

15.0 Entire understanding

This MOU expresses the whole agreement reached between the Parties. Consequently, this Agreement supersedes any previous letter or document of whatsoever nature exchanged between the Parties with respect to this Agreement.

16.0 Waiver

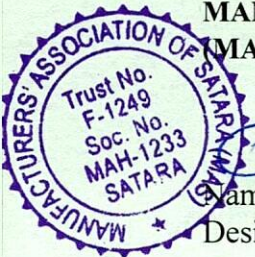
