This Memorandum of Understanding (hereinafter referred to as MoU) is entered into on 10/01/2022 between Janata Shikshan Sanstha's Kisan Veer Mahavidyalaya, Wai located at: Wai, Taluka: Wai, District: Satara - 412803, (herein referred to as Kisan Veer Mahavidyalaya, Wai) and Giristhan Kala Va Vanijya Mahavidyalaya, Mahabaleshwar, Dist- Satara Mahabaleshwar, Tal-Mahabaleshwar, District: Satara 412807. The scope of the MoU, the roles and responsibilities of the parties of the MoU, etc. are as given below:

Alliance Objective:

This document outlines a strategic understanding between Kisan Veer Mahavidyalaya, Wai and Giristhan Kala Va Vanijya Mahavidyalaya, Mahabaleshwar, Dist- Satara to work together to share and offer various activities related to overall development of Students, faculties and institution.

## DEFINITIONS AS USED IN THIS MOU:

1. "MoU" means this instrument executed by between Kisan Veer Mahavidyalaya, Wai and Giristhan Kala Va Vanijya Mahavidyalaya, Mahabaleshwar, Dist- Satara and subsequent amendments issued to the MoU by mutual consent as provided herein.

## Types of Cooperation:

Through this memorandum, both Parties affirm the collaboration and agree to promote the following activities:

- 1. Opportunities for faculty and staff development and Students exchange;
- 2. Exchange of visiting research scholars, including advanced graduate students;
- 3. Joint research projects in fields of mutual interests;
- 4. Exchange of academic publications and reports;
- 5. Other activities as mutually agreed.

This Agreement places no financial obligations or supplementary funding commitments on either Party. These activities will be defined through separate program agreements that detail the commitment of resources (financial or otherwise) required by each Institution. Subsequent program agreements must be approved in writing by the authorized representatives of each institution.

## Terms:

This Agreement will become effective upon the date of signature by both Parties. It shall remain valid for a period of five (5) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both Parties. This Agreement may be terminated by either Party with advance written notice of at least thirty (30) days. The agreement may be extended by mutual consent of the two Parties after the five-year period, and it must be renewed in writing. This MOU will expire automatically on 18th January 2027.
