The scope of the MoU, the roles and responsibilities of the parties of the MoU, etc. are as given below:

Alliance Objective:

This document outlines a strategic understanding between Kisan Veer Mahavidyalaya, Wai and Patil Computer Academy, Satara to offer Python programming Training Program to the students of Departments of the Kisan Veer Mahavidyalaya, Wai viz BCA, Mathematics and Statistics.

DEFINITIONS AS USED IN THIS MoU:

1. "MoU" means this instrument executed by Kisan Veer Mahavidyalaya, Wai and Patil Computer Academy, Satara and subsequent amendments issued to the MoU by mutual consent as provided herein.

Types of Cooperation:

Through this memorandum, both Parties affirm the collaboration and agree to promote the following activities:

- 1. Opportunities for student exchange as per requirement.
- 2. The library resources will be exchanged as per requirement.
- 3. To design and execute short term course on python.
- 4. The Students will be given short projects on python as per requirement.
- 5. Organization of Workshops between mutual co- operations.
- 6. Other activities as mutually agreed.

This Agreement places no financial obligations or supplementary funding commitments on either Party. These activities will be defined through separate program agreements that detail the commitment of resources (financial or otherwise) required by each Institution. Subsequent program agreements must be approved in writing by the authorized representatives of each institution.

Terms:

This Agreement will become effective upon the date of signature by both Parties. It shall remain valid for a period of five (5) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both Parties. This Agreement may be terminated by either Party with advance written notice of at least thirty (30) days. The agreement may be extended by mutual consent of the two Parties after the five-year period, and it must be renewed in writing. This MOU will expire automatically on 28th December 2026.
