MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter referred to as MoU) is entered into on 25/05/2022 between Janata Shikshan Sanstha's Kisan Veer Mahavidyalaya, Wai Taluka: Wai, District: Satara – 412803, (hereinafter referred to as Kisan Veer Mahavidyalaya, Wai) and Akhil Bhartiya Andhashraddha Nirmulan Samitee, Satara, District: Satara 415002. The scope of the MoU, the roles and responsibilities of the parties of the MoU, etc. are as given below:

1. Alliance Objective:

This document outlines a strategic understanding between Kisan Veer Mahavidyalaya, Wai and Akhil Bhartiya Andhashraddha Nirmulan Samitee, Satara to work together to share and offer support in various activities.

2. Types of Cooperation:

Through this memorandum, both Parties affirm the collaboration and agreed to promote the following activities:

- 1. Organization of Conferences, Seminars, Workshops, Symposiums, Vignyan Parishad with mutual cooperation;
- 2. Opportunities for faculty and staff development and exchange;
- 3. Exchange of visiting research scholars, including advanced graduate students;
- 4. To share expertise for students;
- 5. Exchange of academic publications and reports;
- 6. Other activities as mutually agreed.

This Agreement places no financial obligations or supplementary funding commitments on either Party. These activities will be defined through separate program agreements that detail the commitment of resources (financial or otherwise) required by each Institution. Subsequent program agreements must be approved in writing by the authorized representatives of each institution.

3. Terms:

- 1. This Agreement will become effective upon the date of signature by both Parties.
- 2. It shall remain valid for a period of five (5) years from the date of the signature, with the understanding that it may be modified by written mutual consent of both Parties.
- 3. This Agreement may be terminated by either Party with advance written notice of at least thirty (30) days.
- 4. The agreement may be extended by mutual consent of the two Parties after the five-year period, and it must be renewed in writing.
- 5. This MOU will expire automatically on 25thMay 2027.
