



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter referred to as MoU) is entered into on 25/9/2019 between Janata Shikshan Sanstha's Kisan Veer Mahavidyalaya, Wai located at: Wai, Taluka: Wai, District: Satara – 412803, herein referred to as Kisan Veer Mahavidyalaya, Wai and Udyog Utkarsh Samajik Sanstha's Skill Development & Self Employment Training Institute located at 349, Madhli Ali, Vishwakosh Karyalay Chowk, Tal: Wai, District: Satara – 412 803 having its registered address at: Dhom Punarvasan, Post: Ozarde, Taluka: Wai, Dist: Satara – 412 803. The scope of the MoU, the roles and responsibilities of the parties of the MoU, etc. are as given below:

Alliance Objective:

This document outlines a strategic understanding between Udyog Utkarsh Samajik Sanstha's Skill Development & Self Employment Training Institute and Kisan Veer Mahavidyalaya, Wai to work together to offer various Skill Development & Self Employment Training Programmes to the staff & students of the Kisan Veer Mahavidyalaya, Wai. The primary aim of this alliance is to aid Kisan Veer Mahavidyalaya, Wai and its students to develop various Entrepreneurial Skills and take up self employment as a means of income source as well as provide recognition to those who wish to work on wage employment in various sectors and influence the authorities for shortlisting them during the job interview procedures. This will help Kisan Veer Mahavidyalaya, Wai to train and place their students in various sectors and to position them to support the Make in India Initiative.

As opposed to a one time implementation, this is a strategic initiative and requires total commitment of both Udyog Utkarsh Samajik Sanstha's Skill Development & Self Employment Training Institute and Kisanveer Mahavidyalaya Wai. The Skill Development & Self Employment Training Programmes would allow Kisan Veer Mahavidyalaya, Wai to be one of the foremost institutions in Maharashtra in the field of Arts, Commerce and Science, to impart professional education, apart from others to develop their students' personality and make them capable of delivering high caliber skills required in the fast changing marketplace.

DEFINITIONS AS USED IN THIS MoU:

- 1. "MoU" means this instrument executed by Udyog Utkarsh Samajik Sanstha's Skill Development & Self Employment Training Institute and Kisan Veer Mahavidyalaya, Wai and subsequent amendments issued to the MoU by mutual consent as provided herein.
- 2. "Programme" means The Skill Development & Self Employment Training Programmes which is the subject of this MoU.

1. Benefits to the Kisan Veer Mahavidyalaya, Wai:

- 1.1 Opportunity to emerge as one of the competent entities in the academic circles in Arts, Commerce and Science.
- 1.2 Opportunity to be recognized by the industry and academic circles as one of the preferred locations for acquiring training and skill development in the field of Arts, Commerce and Science.
- 1.3 Opportunity to utilize the Programmes to train students on Skill Development and Self Employment.
- 1.4 Opportunity for the faculty and students of Kisan Veer Mahavidyalaya, Wai to be capable of delivering the caliber of various professional soft skills required at present and for the future.
- 1.5 Opportunity for students to avail a Certification which will help them to add weightage to their resume when they face an interview as a fresher which will help them to crack the interviews in various organizations as well as to make them ready to start up their own businesses all over India.

1.2 Benefits to Udyog Utkarsh Samajik Sanstha's Skill Development & Self **Employment Training Institute:**

- 1.2.1 Creation of a resource pool of professionals to boost the existing skill level of the country.
- 1.2.2 Inclusion of Skill Development & Self Employment Training Programmes in the Curriculum of short term courses offered by Kisan Veer Mahavidyalaya, Wai.





1.2.3 Availability of skilled students/ candidates from the Skill Development & Self Employment Training Programmes to various corporate companies and projects which would benefit Udyog Utkarsh Samajik Sanstha in fulfilling its objective as it is a part of its Memorandum of Association.

2. RELATIONSHIP BETWEEN THE PARTIES:

- 2.1 Neither Kisan Veer Mahavidyalaya, Wai nor Udyog Utkarsh Samajik Sanstha's Skill Development & Self Employment Training Institute is or will be an agent or legal representative or partner of the other. Neither of them is or shall be responsible for the debts incurred by the other or be bound by any contracts or representations made by the other or any obligations undertaken by the other. Neither of them is or shall be an employee or franchisee of the other, nor does this MoU create a joint venture or any similar relationship between them.
- 2.2 Neither party will make any representations pertaining to the other or its business or affairs, without the express prior written consent and approval of the other.

3. AREAS OF COLLABORATION:

3.1. Udyog Utkarsh Samajik Sanstha's Skill Development & Self Employment Training Institute:

- 3.1.1 Training curriculum on the respective programmes will be designed by Udyog Utkarsh Samajik Sanstha's Skill Development & Self Employment Training Institute.
- 3.1.2 Certificate of Participation will be provided to all the students participating in the training programme.
- 3.1.3 Stationery and refreshment as mentioned in the proposal letter will be provided to the participants of the training programme.

3.2. Kisan Veer Mahavidyalaya, Wai

- 3.2.1 Providing the Seminar Hall / Auditorium/ Infrastructure: i.e. LCD Projector, microphone, speakers, amplifier, seating arrangements etc, as required for conducting the Training programmes as and when required.
- 3.2.2 Promoting the Skill Development & Self Employment Training Programmes among the students; the costs for the same to be borne by the students / participants / college.
- 3.2.3 Supporting Udyog Utkarsh Samajik Sanstha's Skill Development & Self Employment Training Institute for conducting the proposed training programmes.

4. MONITORING OF IMPLEMENTATION:

A Co-ordinatior of Kisan Veer Mahavidyalaya, Wai should be nominated by Kisan Veer Mahavidyalaya, Wai who will do the planning and coordination of implementation of all the training programmes and activities of Udyog Utkarsh Samajik Sanstha's Skill Development & Self Employment Training Institute. There will be an annual review and feedback. This review would primarily focus on the progress and development of the participants.

5. LIMITATION OF LIABILITY:

Under no circumstance is Udyog Utkarsh Samajik Sanstha's Skill Development & Self Employment Training Institute liable for Kisan Veer Mahavidyalaya, Wai's loss of, or damage to, records or data, as also claims for special, incidental, or indirect damages or for any economic consequential damages (including loss of profit or savings even if Udyog Utkarsh Samajik Sanstha's Skill Development & Self Employment Training Institute is informed of its possibility.





6. Term Period of MOU:

This MOU is valid for a term of five years from the date of Signature of both the parties, unless agreed by mutual consent in writing. This MOU will expire automatically on 12th October 2024.

7. GENERAL:

- 1. This MoU may be terminated by either party through a notice of one month. Either party may terminate this MoU if either of the parties is frustrated by reasons beyond its control from going ahead with the implementation of the provision of this MoU. The provisions contained in Clause 5 (Limitation of Liability) will survive any such termination.
- 2. Neither parties will make any presentations pertaining to the other or its business or affairs, without the express written consent and approval of other.
- 3. It is understood that during the course of this MoU it may be necessary for either party to disclose confidential/proprietary information to the other. The disclosure of any such information or data between the parties shall be made pursuant to an executed Confidentiality Agreement.
- 4. All costs incurred by a party pursuant to this MoU shall be borne by the party who incurred the costs.
- 5. There shall be no liability on the part of any party to the other arising from the termination of this MoU.
- 6. This MoU is not binding on either of the parties hereto, except as specifically set out hereto. This MoU is intended to express the broad understanding of the parties and as a broad framework for working together on a specific opportunity as detailed herein.
- 7. The terms of the training programme and the terms relating to confidentiality under this MoU shall survive the term of the MoU.
- 8. Neither party may use the other's corporate name or any trade mark or name or any other items or assets protected by intellectual property rights, including but not restricted to, use in any promotional material, press releases, advertisements, communications, stationery, websites, or the like.
- The Skill Development & Self Employment Training Programmes offered under the said MoU are
 for the specific purpose set forth in the MoU, namely for training the bonafide students of the
 Kisan Veer Mahavidyalaya, Wai and not for any other commercial purposes.
- 10. Neither party will disclose the existence, or the terms and conditions, of this MoU or any information connected with it or any information received from the other or otherwise during the implementation of this MoU or its subsequent amendments, if any, except as may be required by law or on a strictly "need-to-know" basis for the purpose of implementing this MoU, or its subsequent amendments, if any, unless express prior written consent of the other party shall have been obtained in advance.
- 11. The laws of the Republic of India shall govern this MoU.
- 12. This MoU supersedes all proposals or other prior representations or communications, either oral or
- 13. All communication between the parties shall be in writing and in English Language.
