## Memorandum of Understanding Between

### KISAN VEER MAHAVIDYALAYA, WAI, DIST. SATARA (MAHARASHTRA)

And

#### PARIVARTAN VYASANMUKTI SANSTHA, SATARA (MAHARASHTRA)

The Department of Psychology, Kisan Veer Mahavidyalaya, Wai, Dist. Satara (Maharashtra) and Parivartan Vyasanmukti Sanstha, Satara (Maharashtra) (hereinafter referred to as the "Sides"), taking into consideration the importance of education in national development, and the value of co-operation and policy dialogue in education, have reached the following understanding:

#### **Objective and Principles:**

 This Memorandum of Understanding (hereinafter referred to as the "MOU") intends to set out the general principles of mutual co-operation in the field of education, according to which the Sides may jointly identify areas of mutual interest and carry out co-operative activities on the basis of reciprocity and mutual benefit.

- This MOU will be carried out within the framework of the respective laws and regulations of the two Institutions and is not intended to create any legally binding rights or obligations.
- 3. The co-operative activities under this MOU will be carried out in the fields of higher education.
- 4. The Sides will Endeavour to encourage and facilitate, as appropriate, the development of contacts and co-operation in the field of higher education.
- 5. The Sides will encourage the following co-operative activities, in particular:
  - a) The exchange of information on their respective educational systems and policies to assist in ongoing education reform;
  - b) The exchange and professional development of officials, academics, scholars, counsellors, teachers, experts, students and administrative staff;
  - c) The collaboration between two institutions in joint delivery and research programs and publications, including exchange of research materials, publications and educational literature and educational visits;
  - d) The joint organization of conferences, exhibitions and symposia, workshops on matters of mutual interest.
- 6. The cost of co-operative activities may be funded as mutually determined. All co-operative activities under this MOU will be subject to the availability of funds to the Sides.

# 7. This MOU will come into effect on the date of signature.

This MOU will remain in effect for an initial period of three years and will be extended for successive period of one year, unless either side notifies the other side, in writing, of its intention to terminate this MOU at least three months before the expiry date of the relevant period.

This MOU is signed in duplicate in Wai on the 01<sup>st</sup> day of December, 2018, in English language for the Department of Psychology, Kisan Veer Mahavidyalaya, Wai, Dist. Satara (Maharashtra) and Parivartan Vyasanmukti Sanstha, Satara (Maharashtra).
