Report of One Day Workshop on “How to Manage Money and be Smart Investor” – 11th December 2019

One Day workshop on “How to Manage Money and be a Smart Investor” was organized by Departments of Economics, Commerce and Zoology of our college in association with NSE's Investor Protection Fund Trust and Consumer Guidance Society of India on 11th December 2019. India is vast developing nation in the world and has huge consumer potential from world point of view. Indians are consumers of goods and services produced in inland and international level financial services and products at both level as well. It is important from consumer point of view that, they must aware and know their right and obligation as consumer of products and services. If consumer could be well aware of his rights and obligations then his interest can be preserved. This is the main aim and focusing area of this workshop.

Dr. R.S. Gavit welcomed Chief Guests, Chairperson, all staff and student of programme and requested to all dignitaries on dais to inaugurate programme by enlighten the holy lamp and offer flowers to frames of Hon.
